**COMMODITY JURISDICTION DETERMINATION FOR:
Family of Electromagnetic Interference (EMI) Shielding Products**

Your commodity jurisdiction (CJ) request was referred to the Departments of Defense and Commerce for review and recommendations. The items are used to limit the level of radiated electromagnetic energy from entering or leaving a box, housing, or enclosure containing electrical/ electronic equipment, including ships, tanks and airplanes. This family includes EMI bonding gaskets attached to rubber elastomer extensions, EMI connector seals, and shielded honeycomb air vent filters. Production technologies for these items are widely available internationally, they have widespread commercial and military applications.

The Department of State has determined that the **Family of Electromagnetic Interference (EMI) Shielding Products is not subject to the licensing jurisdiction of the Department of State.** The Department of Commerce (DOC) advises the items are classified as EAR99. Please consult the DOC Office of Exporter Services at 202 482-4811 to determine requirements prior to export.

Should you not concur with this determination and have additional facts not included in the original submission, you may submit a new CJ request. If you do not concur with this determination and have no additional facts to present, then you may request that this determination be reviewed by the Deputy Assistant Secretary for Defense Trade.



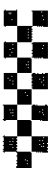
